- 2. President's Report Stephen Breen, Chair, OAMP Board of Directors
 - OAMP responded to the HQO report on EAMD last year. We will set up a working group to investigate how best we can influence the MOHLTC's process to change HARP. Please convey your interest in participating to Board members.

 - In 2018 we will have an election for treasurer.
 - Board activities for the next year:
 - Continue member education and OSSC liaison on professional regulation
 - Establish a working group of EAMD / HARP advocacy
 - Continue to build infrastructure via policy and procedures and social media
 - Election result for secretary

Comments with Financial statement for 2016-2017

The financial statement was prepared on July 6, 2017 by Monique van Prooijen, Treasurer OAMP.

A number of corrections to the financial statement of July 19, 2016 saw our net revenue reduced to \$2379.32 instead of the reported \$2723.39 as of the stated date. The corrections were:

- No evidence of incorporation fees having been reimbursed; reimbursed in 2017
- Membership fee total to date
- Expenses total to date

Our financial year (for tax purposes) is based on a calendar year. Since our AGM is in the middle of the year, I have chosen to show totals for the prior year and sub-totals for the current year as far as data is available. The subtotal for 2017 includes a net income from May that is held in trust at COMP (transfer expected in July).

As a small corporation (annual revenue < \$50,000), we do not owe any taxes, nor do we collect HST from membership fees.

OAMP opened a Community bank account with BMO in Toronto in September 2016. Two board members have access to online banking and debit transactions (President and Treasurer).
